



Acceptable use of Electronic Devices and the Internet - Agreement for Students

Acceptable Use and Conditions

I agree to follow the directions set out below when I use the internet or a log-on account:

- I will use the school electronic devices only with the permission of a teacher.
- I will only use the internet when supervised by a teacher.
- I will follow all instructions from teachers when using school electronic devices.
- I will not give my password out to others.
- I will not let other people log-on to my account.
- I will tell the teacher if I think someone is using my log-on account.
- I will tell the teacher straight away if I see any information on electronic devices that is not acceptable in a primary school environment.
- I will only browse or search appropriate websites.
- I will use material from Internet sites or other sources only if I have permission to do so.
- If I download work or pictures from the internet I will say where it comes from.
- I will not give out my name, phone number, address, name of the school, photographs or other details about myself or others.
- I will take care when using electronic devices and will not change the settings of any electronic devices (including changing wallpapers, themes and screensavers).
- I will not use the school electronic devices to be mean, rude or unkind about other people.
- I will make sure that any comments that I post or any work that I wish to have published is respectful, carefully written and well presented.
- I will not interfere with other people's work, which may result in it being changed, vandalised, lost or deleted.

Unacceptable Use and Consequences

I understand that:

- I will be held responsible for all my actions while using online services and for any breaches of directions;
- I will be held responsible for all my actions if I allow any other person to use my online services account;
- The misuse of online services may result in the withdrawal of access to services and other consequences informed by the Department of Education and School policies; and
- I may be legally liable for misuse of electronic devices and the police may be contacted.

I agree to abide by the acceptable usage agreement for school students at Golden Bay Primary School. I understand that if I am given an online services account and break any of the directions in the agreement, it may result in disciplinary action, determined by the principal in accordance with the Department's *Students Online Policy and Behaviour Management Policy*.

Unacceptable use of Electronic Devices, Network and the Internet and consequences

- All students will be required to complete the Cybersmart Program under the supervision of the class teacher.
- Restorative action will be tailored to meet specific concerns related to a breach of agreement, and assist students in gaining the self-discipline necessary to use online services appropriately.
- Unacceptable use of electronic devices, network or the internet will result in review of student privileges in consultation with the Principal and Parents.
- In the event of a serious breach or repeated offences parents will be informed and access to electronic devices and/or Internet will be determined by the Principal.
