



## **School Board – Principal’s Report November 2016**

### ***SUCCESSFUL STUDENTS***

#### ***Semester Reports***

Semester Reports will be sent home to parents on or before the beginning of week 10. Parents have been invited for interviews with teachers where required.

Early Transition arrangements are in place for students as needed to reduce anxiety. All students will meet with their classroom teacher for 2017 where possible (given staff new to our school next year may not be available given current commitments).

#### ***Reading and Parents as Coaches***

Kathryn Bean and Alyssa Marsh were invited to present at this meeting of the School Board following my previous report table at the last School Board meeting. The presentation was designed to inform and stimulate conversation.

An initial meeting with parents will be held this term.

### ***GOOD SCHOOL***

#### ***National Quality in Schools (NQS)***

Our school Continuous Improvement Team, led by Michelle Nash, Assistant Principal, has worked consistently throughout the year to ensure that we met the NQS standards expected of all schools and Early Years learning centres. After completing our 2016 audit we were invited to have our school self-assessment verified by an external audit process.

On Monday 21 November the Executive Team and staff welcomed the NQS verifiers from Central Office and a Principal from a school judged as exceeding the NQS standards. The verifiers spent the day discussing and examining our strategic plans, documentation, processes and practice. Michelle and I worked closely with the verifiers throughout the day. Staff and children from Kindergarten to Year 2 spent time with the verifiers in their classrooms and play areas where they responded to questions as the verifiers observed our staff and students at work.

We received the formal verification report this afternoon. Golden Bay Primary School has had a resoundingly affirmative report that indicated that all standards had been met to the highest standard as indicated in our Self-Assessment. Staff and parents can be assured that we are strongly aligned with national and state requirements having met the National Quality Standards set for all schools. Our strong alignment in our Business Plan, Strategic Planning documents, school policies and procedures received high praise.

An overview of our conversation against the National Quality Standards has been prepared for distribution to School Board members tonight.

### ***Class Placements***

I am currently working on class lists. Student placement requests were called for from parents. Requests for special consideration need to be to me in writing on or before 2 December. Requests will be given serious consideration in the context of the student needs and class structures.

I will post proposed class lists on the last day of term. Please note that class configurations may change after this date dependent on enrolments.

### ***Enrolments***

Enrolments continue daily with a further forty enrolments this term so far. Our first transportable building is scheduled for instalment in term 1 of next year. It is likely to be placed in the area between Pre-primary and Block 4.

### ***Staffing 2017***

We completed our selection and recruitment process in preparation for 2017 school years. The recruitment team consisted of the Principal, one Assistant Principal, one teaching staff member and a parent representative.

### ***DSTA Funding Allocation***

#### **Quality Staff and Services**

OSHClub has been independently assessed by the Education and Care Regulatory Authority and has been rated against the National Quality Framework as Exceeding what is required, further extending their position as Australia's Highest Quality Provider.017

This body of work will support alignment across schools and provide a consistent approach by our network across K-12 years of schooling.
